

**RESOLUTION NO. 2013-20**

**A RESOLUTION OF RADNOR TOWNSHIP, DELAWARE COUNTY, PENNSYLVANIA, AMENDING THE 2013 WAGE AND SALARY SCHEDULE AND TOWNSHIP ORGANIZATIONAL CHART**

*WHEREAS*, Resolution 2012-152 was adopted by the Board of Commissioners on December 17, 2012 which established the 2013 Wage and Salary Schedule; and

*WHEREAS*, the Board adopted Resolutions 2011-87 and 2011-116 creating and amending the Township's Organizational Chart; and

*WHEREAS*, the Board has informally agreed to a merit increase for one of the Code Official III positions effective February 1, 2013; and

*WHEREAS*, Resolution 2013-17 proposes to create a new Supervisor of Parking & Auxiliary Services position within the Police Department as well as eliminate the salary for the Police Civilian Code Enforcement position as originally approved in Resolution 2012-152; and


*WHEREAS*, if approved, Resolution 2013-17 will require a further amendment to the Organizational Chart; and


*WHEREAS*, in addition to the amendment required as a result of Resolution 2013-17, the Administration is recommending amending the Township Organizational Chart to eliminate the Part-Time Human Resource Manager position in the Finance Department, eliminate the Economic Development Manager position and move the Engineering Inspection Officer from the Community Development Department to the Public Works Department.

*NOW, THEREFORE*, be it hereby *RESOLVED* that the Board of Commissioners of Radnor Township does hereby adopt the amendments to the 2013 Wage and Salary Schedule as detailed in Exhibit A attached hereto and does hereby adopt the amendments to the Township Organizational Chart as detailed in Exhibit B attached hereto.
