A RESOLUTION OF RADNOR TOWNSHIP, DELAWARE COUNTY, PENNSYLVANIA, AUTHORIZING AND APPROVING THE PURCHASE OF ONE DURA TECH MODEL 4012 INDUSTRIAL TUB GRINDER THROUGH THE COSTARS STATE CONTRACT NO. 4400006945 FOR RADNOR TOWNSHIP FROM **FUNDS** FROM THE DEPARTMENT ENVIRONMENTAL PROTECTION GRANT AND FROM FUNDS ALLOCATED IN THE 2010 PUBLIC WORKS EQUIPMENT AND VEHICLES CAPITAL IMPROVEMENT PLAN ACCOUNT

WHEREAS, Radnor Township applied for a grant with the Department of Environmental Protection for funds to purchase a tub grinder in order to enhance the Township's recycling program by enabling the Township to process yard waste and storm damage; and

WHEREAS, Radnor Township has been informed that the Department of Environmental Protection has awarded Radnor Township a grant in the amount of \$495,000.00 for the purchase of the aforementioned tub grinder; and

WHEREAS, the grant awarded by the Department of Environmental Protection is a 90/10 grant, which requires ten percent (10%) of the purchase price to be paid with Radnor Township funds and the remaining ninety percent (90%) to be paid with the grant funds; and

WHEREAS, there is available a Dura Tech Model 4012 Industrial Tub Grinder through the COSTARS State Contract 4400006945 at a price of \$548,398.24; and

WHEREAS, the Board of Commissioners has reviewed and approved the purchase of one Dura Tech Model 4012 Industrial Tub Grinder with the aforementioned grant funds, and now desires to approve the purchase of the same through the COSTARS State Contract 4400006945 in accordance with the Home Rule Charter of Radnor Township.

NOW, THEREFORE, be it RESOLVED that the Radnor Township Board of Commissioners does hereby approve the purchase of one Dura Tech Model 4012 Industrial Tub Grinder through the COSTARS State Contract 4400006945 at the bid price of \$548,398.24 with the Department of Environmental Protection grant funds being awarded to Radnor Township as set forth herein. The Board of Commissioners is only authorizing the purchase of the aforementioned tub grinder if the aforementioned Department of Environmental Protection grant is awarded to the Township. The Board of Commissioners specifically approves the purchase of the tub grinder with the \$495,000.00 the Township will receive from the Department of Environmental Protection grant and the remaining ten percent (10%) balance of \$54,839.00 with Township funds from the 2010 Public Works Equipment and Vehicles Capital Improvement Plan Account.
