## 1. Public Participation

2. Resolution #2019-37 - Awarding Contract #B-19-001, the 2019 Spring Tree Planting Contract to All Season's Landscaping in the Amount of \$38,500

Commissioner Nagle made a motion to approve, seconded by Commissioner Farhy.

The Board of Commissioners authorized the receipt of sealed bids for this project at the regularly scheduled February 25111, 2019, Board of Commissioners meeting. The project provides trees to Radnor Township residents at a cost of \$35 per tree.

Commissioner Borowski called the vote, motion passed 6-0 with Commissioner Clark absent.

3. <u>Resolution #2019-38 - Authorizing the Purchase of Rain Gear and Boots for the Public Works Department Employees</u>

Commissioner Larkin made a motion to approve, seconded by Commissioner Farhy.

The purchase of rain gear for the Public Works Employees has not been previously before the Board of Commissioners. The Public Works Department works outside in all weather conditions performing their jobs of collecting trash, recycling, working in the parks and working on the streets and roadways. The crews need protective, high visibility rain gear and boots to perform their work in a dry and safe condition.

Commissioner Borowski called the vote, motion passed 6-0 with Commissioner Clark absent.
