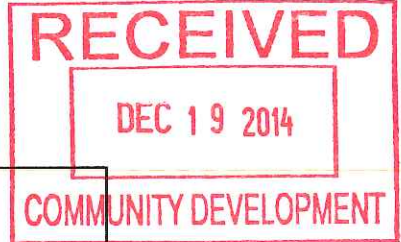

Applicant proposes to adhere two (2) signs to the property. The first sign is 68 3/8 wide x 45 5/8 high. The material is stainless steel lettering with a backer board - painted the same color of the building. The secondary sign, which displays the company name, will be adhered to the siding of the building. It is 98 7/16 wide x 5 5/16 high. 
