2020 Radnor Township Shade Tree Committee Goals - DRAFT - Jan2020

- 1) Implement the Master Street Tree Charter
 - Analyze street data and start park surveys Matt
 - ACTION: Provide list of Hazardous Trees and location to Steve McNelis (~ 65) at survey completion (~ EONov2019) – Matt
 - Address gaps by offering both Spring & Fall Plantings of both large and small trees.
 - DISCUSSION: Should we combine the Spring & Fall Plantings into one Fall Planting since the Conservancy runs a large Spring Tree Giveaway (~ 500 trees)?
 - Explore measuring the tree canopy Frank
 - ACTION: Consider local universities to keep the funds within PA.
