## Waiver, Release and Indemnity Athletic Facilities Events

**In consideration of the releasees (as defined below) permitting the activity, the releasors agree that if any of the releasors incurs any loss of property or injury, including death, as described above, none of the releasors will hold Villanova University, their officers, employees, agents or students (collectively, the "releasees") responsible or seek damages from any of the releasees in any form. Each releasor hereby waives and releases any and all claims against each of the releasees for personal injury, death or property damage arising in any way out of participation in the activity, including, without limitation, any such injury, death or damage arising out of the negligence of any of the releasees, and will indemnify and hold each releasee harmless from any such claims.**

While on the Villanova University and Villanova Athletic Department premises, I agree to conduct myself in a prudent and cautious manner and to be responsible for any damage caused to University's property by me. I certify that I have no medical condition that would prohibit me from participating in the activity and that I have health insurance to cover any medical expenses I might incur in connection with the activity.

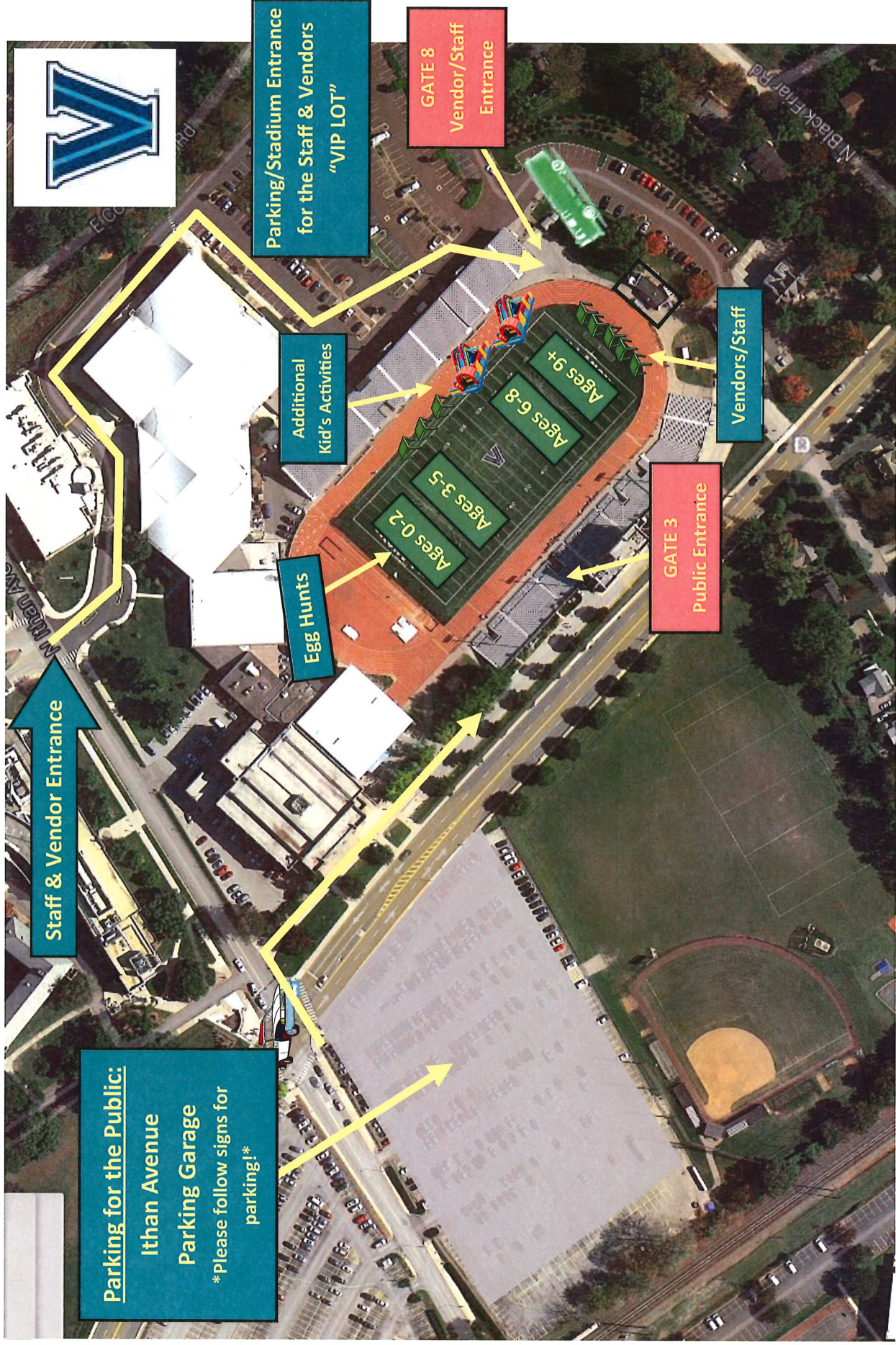
