Parking will be prohibited in this area during the closure and vehicles will be towed. Please see attached map of the event for more details including road closures.

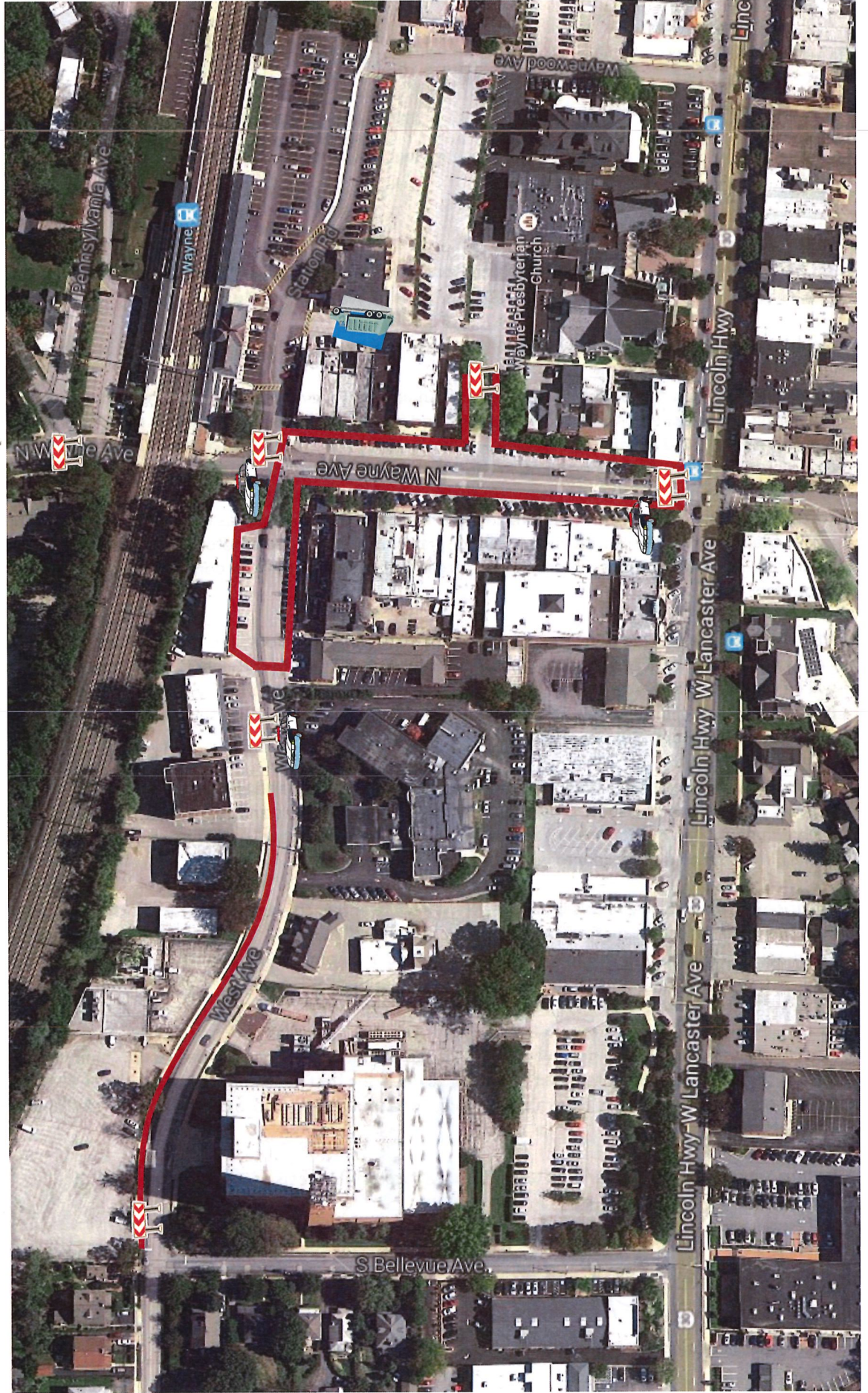
