Theft from Mailbox - 200 block of Upper Gulph Rd.

The resident then checked the mailbox and discovered that a bill payment with a personal check inside of it had been removed.

On February 8, 2022, the resident of the 200 block of Abrahams Lane had mail they placed in their mailbox for pick up, stolen. Taken was a personal check designated to pay bills. This check was altered and cashed fraudulently.

The Radnor Police respects citizens' privacy, civil rights, and civil liberties by emphasizing behavior, rather than appearance, in identifying suspicious activity. Factors such as race, ethnicity, and/or religious affiliation are not suspicious. The public should only report suspicious behavior and situations (e.g., an unattended backpack or package, or someone breaking into a vehicle or restricted area). Moreover, any physical descriptions are based on victim and witness statements provided to the Radnor Police at the time the incident was reported or developed through investigation.

Center for Resolutions Program Descriptions

Mediation Services

The program gives individuals, groups, and organizations the opportunity to resolve conflict outside of the court. Our trained mediators bring people in conflict together and facilitate a constructive conversation to assist them in creating their own mutually satisfying agreement. Individuals, the court system, local police departments, and local agencies utilize and refer cases to our mediation services. Center for Resolutions utilizes over 36 volunteer mediators. We have seen a significant increase in mediation requests during the pandemic.

Peer Mediation Program

Our peer mediation program is designed for elementary and secondary schools. We train and support students to offer mediation to their peers as an option for resolving conflict. When conflict arises and students do not know how to communicate openly and honestly, the conflict tends to escalate and grow. Peer mediation programs provide youth and adults with the tools and skills to resolve conflicts nonviolently.

Benefits

- Develops problem-solving, decision-making, and leadership skills.
- Creates stronger interpersonal and inter-group relations.
- Empowers students.
- Builds conflict resolution skills through real life practice.
- Improves self-esteem.

The Center for Resolutions works with school districts to develop and implement a peer mediation program. We provide peer mediation training for students and school staff, consulting to develop and implement a successful peer mediation program and follow up services.

Supervised Visitation-Reunification Program

Center for Resolutions provides non-custodial parents and their children a safe and secure space to preserve the parent/child bond and promote stronger family connection. Visits are completely confidential and facilitated by trained and impartial supervisors. Furthermore, focus is placed on the importance of the family relationship and parent engagement. The visitation center provides access to families in need in a safe and respectful environment. Documentation is provided to courts that may support the reunification plan outlined by the judge.

Youth Aid Panel

Youth Aid Panel (YAP) is a diversionary program for Delaware County juveniles that have committed a first-time summary level offense (i.e. underage drinking, small amount of marijuana, disorderly conduct, retail theft, etc.). We partner with police departments that refer the cases to a panel of volunteers that represent the community they are serving. Currently, there are 225 panelists representing 35 police departments in 41 municipalities across the county. Our trained panels are poised to intervene in the lives of these young people at the first moment they begin to make poor decisions. After an extensive interview with the youth and parents or guardian, a panel mentor is assigned to help them through the process which typically takes between 2 and 3 months to complete. The panel creates resolutions, or assignments pertinent to the offense committed and the individual youth's needs, interests, or goals. These resolutions are creative and allow the youth to learn form their mistakes through a restorative justice model, as opposed to punitive measurements from the juvenile justice system.

If the youth successfully completes the program, they do not receive a juvenile record, allowing the youth a fair opportunity at success such as applying to colleges, jobs, and the army. Our goal is to assist youth and families most in need by bringing conflict resolution skills and resources to Delaware County.

The Center for Resolutions has several programs that are specifically designed to the needs of the individual youth. "Teen Intervene" in collaboration with Child and Family Focus is a program that deals with drug and alcohol use and consists of two sessions. Both sessions must be attended by the youth, with the parent/guardian attending for a portion of the second session. The "My Path Ahead" class is geared to youth who generally lack direction regarding their future and provide them with specific strategies to help them develop a plan for their future success. The "Problem Solving and Decision Making" class concentrates on 5 areas, identifying problems, creating alternatives, evaluating these alternatives, deciding the best course of action, and measuring results. The "History in my Backyard" class is for youth to learn from Veterans and their experiences. Youth also help beautify the memorial site for completion of resolution. Classes are held at the Delaware County Veterans Memorial in Newtown Square.

In addition, the Center for Resolutions offers several community service projects as resolutions.

The feedback from the teens who attend classes has been extremely positive and we believe it will help them to make better decisions when questionable situations arise in their future. The Youth Aid Panel Program has the youth and community working collaboratively to shift the youth from the label of "criminal" to feeling empowered, educated, and connected to their community.

Center for Resolutions Training Programs

(all trainings are approved for continuing education credits)

<u>24-hour Basic Mediation Training</u>: This introductory training is designed for individuals interested in learning to mediate and/or develop skills in conflict resolution. Content includes understanding the dynamics of conflict, active listening, asking effective questions, using neutral language, handling special problems, framing negotiable issues that lead to joint problem solving, agreement building and mediator ethics.





Joint Radnor Emergency Services Meeting 2022-#1

On Wednesday, February 23, 2022, at 1300 hrs. the first meeting of 2022 for Radnor's Joint Emergency Services was held virtually using Microsoft Teams. In attendance were members of Fire, EMS, Codes, IT, and Police who provide service to the Radnor Township Community. Radnor President Commissioner Mulroney also attended the meeting.

The representatives included:

Police: Radnor PD - Superintendent Flanagan, Lt. Joe Pinto, Lt. Chris Four **Fire:** Radnor Fire Co. – Chief Joseph Maguire, Deputy Chief Michael Maguire

Broomall Fire Co. - Chief Thomas Dobbins

Codes: Andy Pancoast

IT: Bob Hale, Steve Giancristoforo Emergency Management: EM/Sgt. Gluck

This meeting was held to discuss new topics and to follow up on previous items.

Topics which were discussed at this meeting include the following:

- Discussed the status of the Knox Box Program
 - Sgt. Gluck advised the new Key Secure 6 (Ekey) hardware has been installed in all RFC apparatus and 2 Broomall Fire Co. apparatus. Instillation of this system is pending for 2 Broomall Fire Co. apparatus and 2 Radnor Police vehicles.
 - o Knox will update their website the 1st week of March 2022 to make Ekey Knox Boxes available for purchase. The site will also show the Ekey lock available for purchase if any Knox Box owner would like to change their key tumbler from mechanical to Ekey so an audit trail can be completed.

- O Sgt. Gluck noted a 2-sided post card with information and QR codes has been placed at the Community Development service window at the Township building. The QR codes can be scanned by a smartphone leading to the Knox Box purchase website and the Township Rapid Entry Code, Ch. 183. The same links and information will be added to the Township website under the Community Development and Emergency Management pages soon.
- Discussed the status of CodeRED Emergency Notification System
 - o Steve Giancristoforo advised the notification system is up and running
 - o An "All Call" was activated on December 11, 2021 at 1600 hrs.
 - The call went out to:
 - 3,182 email accounts
 - 15,744 phones (landline & Cell)
 - 2,451 text accounts
 - 21 TDD
 - Facebook
 - Twitter
 - o Members of the Joint Emergency Services meeting were asked to sign up for the alerts
- Public Works Water Safety Equipment
 - Sgt. Gluck advised 10 water safety helmets (red), 10 flotation vests, and 5 sounding sticks were purchased and obtained for Public Works staff members to use if need be during flooding events. This equipment will be used to protect staff members should they need to conduct debris removal during heavy rain events.
 - All Public Works staff will take part in Water Safety Awareness training here at the Township building in the near future. This training will be instructed by certified instructors through the Montgomery County Fire Academy.
- Upcoming Event: The Wayne Music Festival 2022
 - O Sgt. Gluck advised a preliminary meeting was held with members of the Wayne Business Association who advised the event is schedule for June 11, 2022. All members were advised to be aware of this event due to the large number of spectators it will bring to the area. Once the event is approved by the Radnor BOC, further planning will begin.
- Upcoming Event: March Madness 2022
 - o Sgt. Gluck advised Villanova Men's Basketball is currently ranked 8th and will be involved in March Madness. Selection Sunday is March 13, 2022.
 - o Further planning will begin once closer to the event
- Discussed the status of the Township Fire Inspector
 - Sgt. Gluck advised at this time the job description has been created by Community Development and now awaits approval before posting.
- Discussed the involvement of Township Commissioners in the Emergency Services Meetings
 - A request to discuss having a Township Commissioner involved in these meetings was expressed. Commissioner Mulroney advised she will review what steps will need to be taken to have some level of involvement at the BOC level.
- Discussed ways to obtain water depths for Fenimore Woods Pond & Willows Pond
 - Due to recent discussions about safety concerns over persons using Township ponds during the winter months for ice skating this topic was brought forward. A request was made to have a better idea of the water depths of these ponds.
 - o Sgt. Gluck advised a broad depth analysis can be done with the assistance of Public Works or a more thorough study can be done through Engineering.
 - o It was determined once warmer weather arrives, we will ask Public Works to get a generalized layout of the pond depths with RFC members on standby for safety

purposes. This initial step will be completed to see if a more accurate study will be needed.

- RFC Deputy Fire Chief Maguire provided an update on Specialized Ice/Water Rescue Training
 - Deputy Chief Maguire advised he and Assistant Fire Chief Paul Leighton completed Ice Rescue training.
 - Deputy Chief Maguire further noted Radnor Fire Co. has applied for their Swift Water
 Rescue Certificate through the State and are awaiting the approval.
 - Deputy Chief Maguire advised of the following staff training levels relating to ice water rescue:
 - 39 RFC members have Ice Rescue Awareness Level certifications
 - 39 RFC members will be trained next week at the Operations Level
 - 8 RFC members have Ice Water Technician Level certifications
 - 22 RFC members have Operations Level certifications
 - 14 RFC members have advanced lines certifications
 - 8 RFC members have Boat Operation certifications
- RFC Director of EMS Operations Zimmerman provided an update on the newly added RFC Ambulance location at Penn Medicine, 145 King of Prussia Rd.
 - o Director Zimmerman advised this location is in addition to Radnor Fire station
 - o The Penn Medicine location will be used if staffing permits and operate M-F 9 am to 4 pm.
 - O Director Zimmerman advised since the adding this location there has been an approximate 5 min reduction in ambulance response times to the Eastern side of the Township.

St.Katharine's School is an integral part of our Midland Avenue/South Wayne community and family. It's probably safe to say that there isn't a community or family, in existence, that is perfect. We can all relate to having to tap into grace, patience, and mindfulness to tolerate the seemingly intolerable; the less than desirable parts of people and situations within our families and communities.

We acknowledge that the SKS carline, a permanent necessity, is a tangible example of a sometimes less than desirable situation within our community. After several meetings and discussions, we've collectively decided it is of the utmost importance to communicate our sincerest gratitude to everyone involved in or affected by the SKS carline. We also acknowledge that it's sometimes frustrating to have a carline in front of your home, or, if you're in the carline, to be asked to move your car if you are unaware that you're obstructing someone's driveway. We sincerely thank you and encourage you to keep practicing patience and mindfulness in these instances.

Together, we've examined every possibility of carline formation and have come to the conclusion that the carline needs to remain where it is. Radnor PD and SKS have worked together to double up the carline once it gets to the SKS gates to have cars move quicker off of the 300 and 400 Midland blocks. Since then, the carline flow has been clocked by Radnor PD from start to finish between 9-13 minutes. For those who are SKS drivers, realizing that not everyone lives in close proximity to SKS, we ask that you wait in a public parking lot nearby if you need to get closer to school and then get in line no earlier than 2:40. Citations will be issued for blocking and turning around in driveways.

With the conscientiousness of a community and family that cares for one another, we can turn a less than desirable circumstance into a tolerable one by adhering to the carline rules, being mindful of residents, and practicing patience. If anything comes up and you need assistance, please don't hesitate to reach out to any of us.
