2022 NCAA Men's Basketball Tournament - EOC Activation

In Early March 2022 the Radnor Township Office of Emergency Management began to review previous efforts taken during the NCAA "March Madness" Tournament, specifically 2016 & 2018, when Villanova's team advanced and won the Championships for those years.

The 2022 First & Second Round tournament schedule showed Villanova advancing as follows:

Friday, March 18, 2022:

(2) Villanova vs. (15) Delaware W – Score: 80 – 60

Sunday, March 20, 2022:

(2) Villanova vs. (7) Ohio St.

W – Score: 71 – 61

On Monday, March 21, 2022, a meeting was held internally to begin pre-planning our Township's public safety efforts should the Villanova men's basketball team advance through the NCAA "March Madness" tournament.

Sweet 16 Round:

Thursday, March 24, 2022:

(2) Villanova vs. (11) Michigan

W – Score: 63 – 55

On Friday, March 25, 2022, further meetings were held to continue the planning process. Outside agencies were contacted and advised their assistance would be needed.

Elite 8 Round:

Saturday, March 26, 2022:

(2) Villanova vs. (5) Houston

W – Score: 50 – 44

Radnor Township Police and Public Works were detailed to Villanova University to aid with traffic control and possibly crowd control during the Elite 8 game. Villanova provided food trucks and a DJ for entertainment for students on campus after the game.

Just as the game concluded, Radnor Public Works did a great job closing Lancaster Ave. alongside Radnor Police. The area was clear for pedestrian traffic.

An unrelated car fire on Dougherty Drive was handled quickly. Members of VU and detailed RPD Officers immediately began to mitigate the incident with fire extinguishers. Bryn Mawr Fire Co. responded to complete diminishing the flames. The area was made safe and the vehicle was quickly removed via tow.

Once it was determined the crowd would stay on campus the roadway was opened in a timely manner.

On Saturday, March 27, 2022, an internal virtual meeting was held to continue planning.

Throughout the week several more meetings were held with all stakeholders who would provide assistance to our Township. The EOC was constructed in the Radnorshire room and our IT team did a great job testing and tuning the equipment as needed.

Final Four Round: Saturday, April 2, 2022

The EOC became operational at 4:30 pm. Officials from various public safety agencies prepared for the event and began to share information. The use of varying levels of patrols and multiple forms of technology allowed for the EOC operation to function at a high level. Communication between those in the field and in the EOC flowed clearly.

During the incident a triage center was operated by members of Narberth Ambulance and Radnor Fire Co. Ambulance staff. A total of 5 patients were treated and released for various non-life-threatening injuries.

Additionally, added patrols were provided to all restaurants and bars within Radnor Township during and after the Final Four game.

Game Score: (1) Kansas 81 vs. (2) Villanova 65.

At the conclusion of the game the crowd exited the Pavilion without issue. Once it was determined the campus was safe for pedestrians and vehicular traffic, the EOC was closed at 9:00 pm.

I believe the planning and operational period went well and provided a positive experience for all who were involved ranging from students to residents, the University to local businesses, and all public safety agencies involved.

Background and Introduction

USDA APHIS Wildlife Services (WS) was requested by Radnor Township to continue a white-tailed deer damage management program throughout Radnor Township, PA in 2022. Deer surveys were conducted by WS during January of 2022 and the results estimated an average deer density of 37 deer per square mile for the entire township. Radnor Township decided to continue deer removal operations in the winter and spring of 2022 to reduce deer densities; thereby, minimizing damages related to deer-vehicle collisions, forest regeneration, species diversity, and other human health and safety concerns. WS was successful in removing 200 deer throughout the township during 9 nights of removal. WS conducted operations under the Pennsylvania Game Commission's (PGC) Special Use Permit (No. 54699) issued to Radnor Township. The following includes program methodology, results, analyses, and recommendations.

Methods

Deer Removal. -WS conducted deer removal activities based upon a protocol that was established by the collaborative effort of Radnor Township, WS, and the PGC. All deer were removed by mobile units as no stationary or tree stand work was conducted. Each mobile unit consisted of two WS employees and two Radnor Township employees. Bait sites were placed to draw deer out of dense cover and into pre-selected areas to position them for safe shooting. Shooting was conducted by highly qualified WS employees with a .22-250 caliber sound-suppressed rifle using highly frangible ammunition.

WS utilized a hand-held Forward Looking Infra-Red (FLIR) unit to locate and observe deer in darkness. These capabilities also further enhanced WS' ability to ensure safe removal operations by detecting people, non-target animals, ricochet hazards, and buildings. Shots were taken using spotlights with red-filtered lights. Deer selection was conducted by targeting adult antlerless deer first. Remaining deer were removed on a first opportunity basis provided safe shots could be taken. WS recorded data for each deer removed including gender, age, time, location, and Tail Fat Score.

Collection of Biological Data. - Ages of deer were determined by evaluating tooth eruption and wear. Ages were recorded to the nearest half year. This method of aging deer is accurate up to 6.5 years of age.

Analysis of the deposition and retention of fat reserves in deer gives an indication of their health and nutrition. WS selected Tail Fat Score, which is an index of deer health appropriate for live deer or deer carcasses that were not eviscerated at the time of examination. As deer accumulate surplus nutrition, fat reserves are deposited first around the internal organs (e.g., around the kidneys), next along the inside of the body cavity, and finally between the muscle and skin (e.g., subcutaneous fat along the tail = Tail Fat Score). Fat reserves are used by the body opposite the order of deposition when food resources are limited. Therefore, in years of low or poor food availability, fat will not be deposited throughout the body. Likewise, in difficult

winter conditions deer will expend fat quickly starting with subcutaneous fat. Tail Fat Score is an appropriate, rudimentary measure to assess deer health. Tail Fat was scored by palpation at the base of the tail on a scale from 0-3. A score of 0 represented no fat under the skin with bones of the tail readily felt. A score of 3 represented ample fat reserves so that no muscle or bone was readily felt.

Results and Discussion

Deer Removal. - Deer removal operations consisted of 9 nights with one mobile unit operating per night in the township. WS removed a total of 200 deer, including 61 deer on Radnor Township property, and 139 deer on private property throughout Radnor Township. The average number of deer removed per night was 22. Operations were typically conducted from 9:00 PM to 5:00 AM (Table 1).

Every deer removed from Radnor Township was taken to an approved processor, packaged, and donated for charitable food distribution. A total of 6,600 pounds of venison was donated by Radnor Township as a result of the cull in winter/spring 2022.

Estimated Deer Densities. -Management operations have removed 1,682 deer since the inception of deer removal in the fall of 2012. This level of removal has decreased the estimated deer density from a high of 101 deer per square in 2012 to a low of 11 deer per square mile in 2015 (Figure 4). Radnor Township has decided that an optimal deer density throughout the township would fall in the 15-20 deer per square mile range. Even though optimal deer density appears to have been achieved at the conclusion of removal each year, assuming an approximate population growth of 30% after fawning, it is important to continue monitoring deer damage and deer density numbers. This can be achieved through population surveys as well as deer vehicle collision data, crop loss and damage, forest regeneration, public perception, and complaints by residents. If damage is still at an unacceptable level utilizing all these monitoring techniques, Radnor Township should adjust the optimal deer density accordingly to achieve an acceptable level of damage.

Deer Biological Data. - Of the 200 total deer removed, 91 were females, 62 of which were 1.5 years or older and 29 were yearlings. Of the 109 male deer removed, 71 were 1.5 years or older and 38 were yearlings. The 62 female deer over the age of 1.5 would have conservatively produced an additional 109 fawns this spring. The total projected deer density impact reduction as a result of the sharpshooting conducted by the USDA WS is 309 less deer in Radnor Township in the spring of 2022.

Removal statistics show that a large percentage of the deer population in the township is 2.5 years of age or younger, as 88% of the deer removed fell into this age class. This number is higher than previous years and is likely due to sharpshooting not taking place in Radnor Township in 2021. Deer removal in Radnor Township historically has removed a large percentage of deer 2.5 years old or younger. Reasons for a relatively young deer population is

most likely influenced by the lack of natural predators and the minimal success of sport hunting taking place in the township. These factors allow fawn survival rates to be extremely high, which promote a young population. A reoccurring young deer population helps justify the need for sharpshooting to prevent further increases in population and to minimize deer related damage.

Tail Fat Scores in Radnor Township were similar to other projects in Southeastern PA, that were conducted around the same time (Figure 3). Tail Fat Scores will continue to decrease until food resources become abundant and fat reserves can be resupplied. At the conclusion of deer removal in April 2022, tail fat scores were likely still decreasing or remaining constant. Tail fat scores in Radnor Township did decrease as the winter continued. This shows that most deer were using up their fat reserves throughout the winter due to a lack of food resources in the general area, too much competition for food from other deer, or both. Even adult females, who typically are the healthiest and able to survive harsh conditions, began to use up some of their fat reserves.

Logistics of Deer Removal. - Radnor Township personnel did an excellent job preparing bait stations and informing WS where deer were being observed regularly in the township. This aided WS greatly in efficiently removing deer. Approximately 15-20 bait stations should continue to be utilized per night of removal. Bait stations should be distributed throughout all of Radnor Township and should be located in areas where deer have been regularly observed.

Even though Radnor Township has done an excellent job securing private properties since removal began in 2012, deer were periodically observed on private properties that WS did not have permission to access. Private properties where deer are commonly observed should be visited in attempt to obtain permission for WS to safely and humanely remove deer. With written permission from a landowner using a standard WS Form 12A, WS may access and remove deer on any private property within Radnor Township. WS recommends that Radnor Township continues to make contact with landowners throughout the township to gain additional properties for future operations.

Recommendations

- Continue to monitor deer abundance via surveys and set removal goals based on reducing the number of deer vehicle collisions in Radnor Township each year.
- Continue annual deer removal operations working toward Radnor Township's deer management goals. WS recommends at least 6 nights of removal in 2023.
- Gain additional access for deer removal on private properties, Radnor Township Public Schools, Villanova University, Cabrini College and all Radnor Township public parks.
- Continue to utilize sport hunting and bow hunting clubs to assist with reducing the deer density as much as possible.




Figure 2. Age distribution of 200 white-tailed deer removed by USDA APHIS Wildlife Services via sharpshooting in Radnor Township, PA February through April 2022.




Figure 3. Comparisons of average white-tailed deer Tail Fat Score on a scale from 0 to 3 with 0 indicating no tail fat. Deer were removed by USDA Wildlife Services via sharpshooting in Radnor Township, PA February through April 2022.





Figure 4. Estimated deer densities as calculated from each set of roving spotlight surveys conducted in Radnor Township.




DEER DENSITY


DEER PER SQUARE MILE
