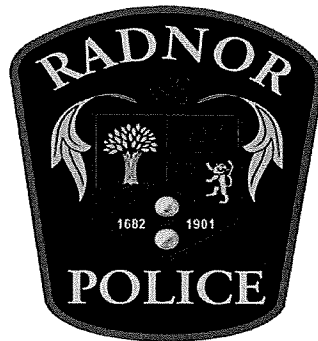

Counterfeit Money - Wayne Business District

DiBruno Brothers and the White Dog Café both received the counterfeit money from what is believed to be the same actor. The actor is described as a black male in his thirties, wearing a white shirt, dark shorts, and a black baseball hat with the Boston "B" on it. The actor is believed to have left the area in older model silver Toyota sedan. In both cases the actor made small value purchases and use the counterfeit \$100.00 bill for payment.

Criminal Mischief to Radnor Township Parks

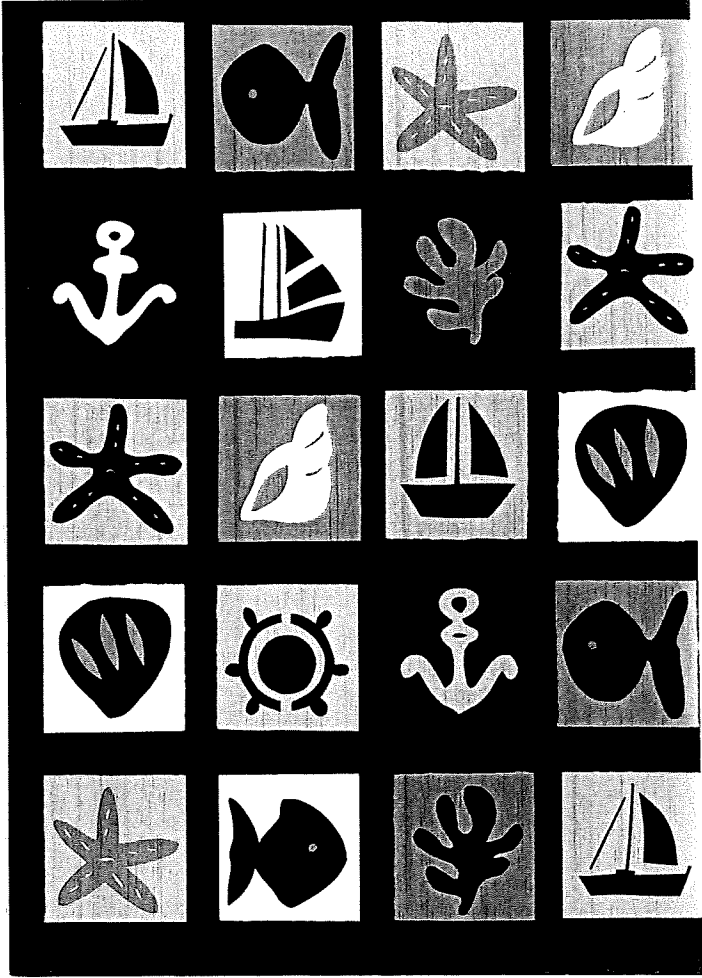

During the week of 8/29/2022 two Radnor Township Parks were vandalized. The Skate Park, located on Creek Drive, had unknown writing spray painted on one of it's skate ramps and one of the restrooms in Emlen Tunnell Park (Garrett Av.) had the sink ripped from the wall.

The Radnor Police respects citizens' privacy, civil rights, and civil liberties by emphasizing behavior, rather than appearance, in identifying suspicious activity. Factors such as race, ethnicity, and/or religious affiliation are not suspicious. The public should only report suspicious behavior and situations (e.g., an unattended backpack or package, or someone breaking into a vehicle or restricted area). Moreover, any physical descriptions are based on victim and witness statements provided to the Radnor Police at the time the incident was reported or developed through investigation.

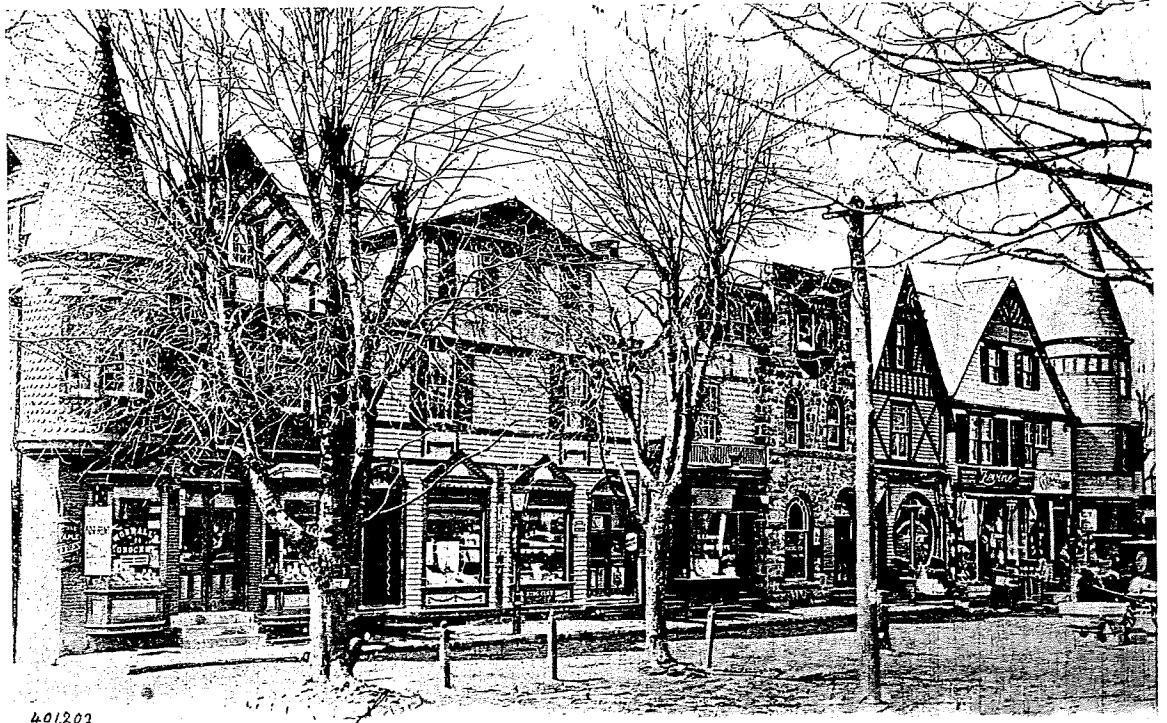

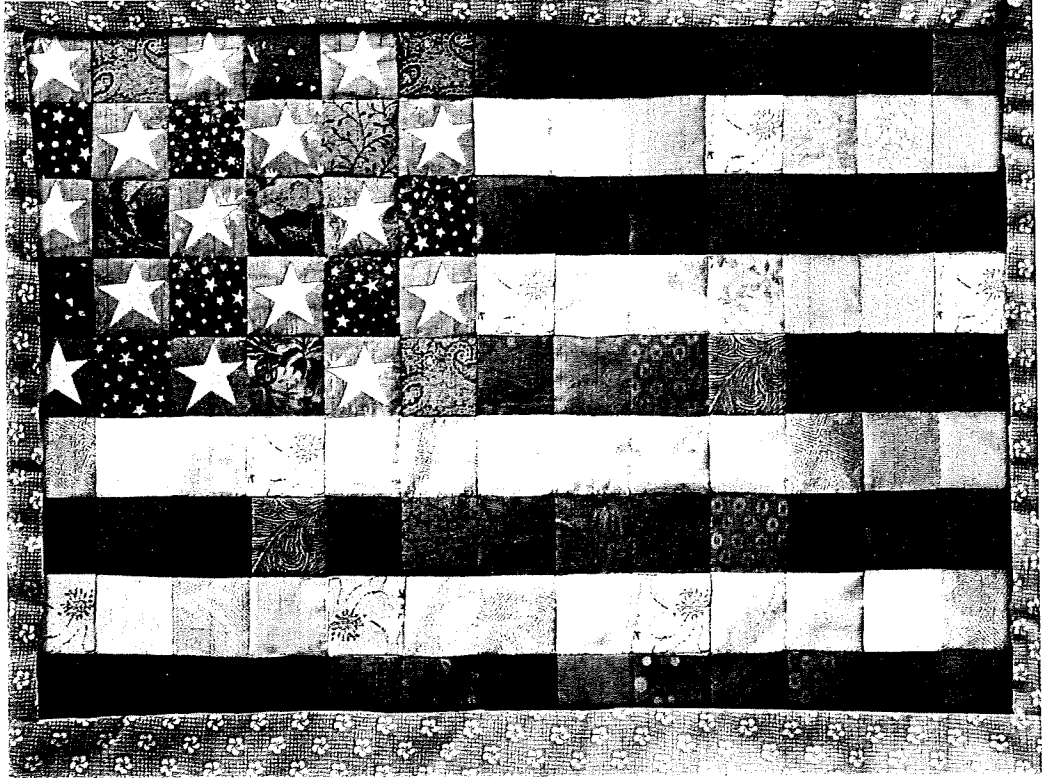

I want to express my formal gratitude to your department for helping during a medical emergency on Tuesday August 9, 2022.

At 1120hrs police and medical personnel were dispatched to a home in Marple Township for a report of a five-month-old in cardiac arrest. Within one-minute police arrived and took over life saving measures from adults on scene. Those measures continued vigorously on scene until the infant could be transported to the hospital. As soon as Marple Police OIC John Murrin was informed that Bryn Mawr Hospital was the location, he requested assistance from Radnor PD, via the Sector 2 dispatcher, in shutting down intersections & providing traffic control to allow the ambulance uninterrupted access to Bryn Mawr's ER.

Your officers working that day responded rapidly and effectively. Their presence at intersections and the hospital entrance provided a sense of great pride and comfort for the parents, Marple Ambulance personnel, Marple police officers escorting the ambulance, and myself personally. It pains me to tell you that our patient, Bennett, did not survive. Despite the relentless efforts of first responders and hospital staff, there was nothing more that could be done for him. He was pronounced by the attending physician about 30 minutes after arriving at Bryn Mawr Hospital.

On behalf of everyone previously mentioned, please extend my thanks to those officers who did what they could to help save a baby's life. I believe that all involved can take solace in the idea that they did everything humanly possible for that little guy, but God's plan for Bennett transcended all.
