## CRIME ALERTS FEBRUARY 2023

#### Retail Theft - 201 Bryn Mawr Av. - Wawa Store

On Wednesday, 2/1/2023, at approximately 12:27 AM a retail theft occurred the Wawa Store, located at 201 Bryn Mawr Av. Store employees report a black male, wearing an orange hooded sweatshirt, ran out of the store without paying for items in his possession.

#### Catalytic Converter Theft - 145 King of Prussia Rd. - Penn Medicine

On Thursday, 2/9/2023, the victim reported that the catalytic converter was removed from their vehicle. The victim parked their vehicle in the parking garage of 145 King of Prussia Rd., Penn Medicine, at 6:45 AM. When the victim returned to their car at 4:30 PM, the catalytic converter had been stolen.

#### Commercial Burglary - 135 N. Wayne Av. - Station Cafe

On Saturday, 2/11/2023 the Station Café, located at 135 N. Wayne Av., reported a burglary that had occurred over night. Video shows a white male, no further description, entering the store, after forcing open a window, and stealing items from the store. Store employees observed the male when opening for the day, but did not report the incident until several hours later.

#### Crime Alert - Assault - Aldwyn Lane

On Tuesday, February 14, 2023, at approximately 10:24 p.m., Radnor Township Police Department were dispatched to the SEPTA Route 100 line on Aldwyn Lane in the Villanova section of Radnor Township for a reported fight involving a weapon. The actor was described as a black male wearing a black puffy jacket, black pants, black boots, and a black winter hat. During the altercation the actor displayed a firearm. The actor fled on foot across the Villanova University pedestrian bridge. The actor is known by the victim to frequent the rail system.

Radnor Township Police, assisted by Villanova University Police Department, SEPTA Police Department and Haverford Township Police Department checked the neighboring streets and campus extensively with negative results. Out of an abundance of caution, the University established a shelter-in-place which has since been lifted.

There is no threat to the University or Radnor community at this time. Anyone with information is asked to contact Radnor Township Police Department Detective Unit at 610-688-0503.

#### Attempted Theft of a Wallet - 550 E. Lancaster Av. - Home Goods Store

On Sunday, 2/19/2023, at approximately 12:29 PM, the victim reports someone attempted to steal their wallet while shopping at the Home Goods Store, located at 550 E. Lancaster Av. The victim advised that a black female, wearing a light brown trench coat and a baseball hat, asked her to retrieve an item from the shelf. The victim assisted the actor and when they turned back around, the black female was observed removing the victim's wallet from her bag. The victim was able to take back her wallet and the black female fled the store.

#### Theft/Burglary - 200 block of Highland Av.

On Sunday, 2/19/2023, at approximately 12:55 PM it was discovered that a vehicle was entered and The Second Baptist Church was broken into, both in the 200 block of Highland Av.. Police were able to determined that an unlocked vehicle in the area was gone through, and loose change and a work ID were stolen. Also the Second Baptist Church had its rear window broken and it appears that an unknown subject or subjects entered the church. In both cases there were signs that the actor or actors were smoking marijuana in the vehicle and the church.

#### Theft of Wallet - 4 West Av. - the Great American Pub

Sometime Friday night, 2/17/2023, the victim had their wallet stolen while they were at the Great American Pub, located at 4 West Av. The theft is believed to have occurred sometime between 10:00 PM and 1:00 AM.

#### Attempted Theft of Auto - 400 block of Fairview Av.

Sometime between 11:00 PM on 2/19/2023 and 8:00 AM on 2/20/2023, the victim reported someone attempted to steal their vehicle from the 400 block of Fairview Av. The victim discovered the steering column of the car had been broken and it appeared someone attempt to start the car with a screw driver. Damage to the car's ignition was visible as well.

#### Theft of Credit Cards - 109 W. Lancaster Av. - Color Me Mine

On Monday, 2/20/2023, at approximately 6:34 PM the victim discovered several of their credit cards were stolen while they were inside of the Color Me Mine store located at 109 W. Lancaster Av. The victim only became aware of the theft after they started to receive alerts about suspicious activity from their credit card companies.


#### Retail Theft - Fine Wine and Good Spirits - 127 W. Lancaster Av.

Management of the Fine Wine and Spirits, 127 W. Lancaster Av., reports a retail theft occurred on 2/17/2023 at approximately 8:33 PM. The management reported the actor to be a black male, in his mid twenties, with dreadlocks. Management further reports that the male regularly frequents the store at around the same time. Most of the time he drives a white sedan, possibly a Dodge and is in the company of several other black males. Management believes the additional black males fit the descriptions of actors who are responsible for additional retail thefts at their store in Devon, PA.

The Radnor Police respects citizens' privacy, civil rights, and civil liberties by emphasizing behavior, rather than appearance, in identifying suspicious activity. Factors such as race, ethnicity, and/or religious affiliation are not suspicious. The public should only report suspicious behavior and situations (e.g., an unattended backpack or package, or someone breaking into a vehicle or restricted area). Moreover, any physical descriptions are based on victim and witness statements provided to the Radnor Police at the time the incident was reported or developed through investigation.


