CRIME ALERTS MAY 2023

Theft of a Motor Vehicle/Theft from Vehicle - Woodcrest Rd/Gulph Creek Rd.

Sometime over night between 4/30/2023 and 5/1/2023 vehicles were entered on Gulph Creek Rd. and had items stolen and a vehicle was stolen from the 700 block of Woodcrest Rd. The stolen vehicle was a 2022 black Nissan Sentra and the keys were left inside of the car.

Crime Alert - Suspicious Vehicle

On 5/11/23, Radnor Police responded the 400 block of Wyldhaven Road for a report of a suspicious vehicle. Caller stated a blue Toyota mini-van pulled up in front of their house and the driver began speaking with the children. The vehicle had several red magnets with the letters "LS" on the side. Anyone with additional information is asked to call 911.

Burglary/ Unit block of Tyler La.

On Friday, 5/12/2023, at approximately 2:11 AM a residence on the unit block of Tyler La. was burglarized. An unknown male, wearing a winter cap, a surgical mask, black sweatshirt and gray sweat pants entered the residence by smashing out a window. Once in side the actor spray painted graffiti at various locations throughout the premises.

Theft - 800 block of Countyline Rd.

On Sunday, 5/14/2023, at approximately 2:53 AM, three flower pots were stolen form outside of the property in the 800 block of Countyline Rd. Video surveillance showed a black male, in his late 50s, with a medium sized white beard, removing the flowers.

Catalytic Converter Theft - 145 King of Prussia Rd. - Penn Medicine

On Tuesday, 5/16/2023, the employee of Penn Medicine, located at 145 King of Prussia Rd., reported the left of the catalytic converter from their vehicle. The victim reports they parked their car in the parking garage at 5:40 AM and when they returned to their car at 3:55 PM the catalytic converter was gone.

Witness report seeing a black male subject exit an unknown gray vehicle and smash a parked vehicle's passenger window and remove an item from the car. The victim was located and confirmed their purse was stolen from the car's front seat.

Suspicious Circumstance - 100 block of Woods La.

On Friday, 5/19/2023, at approximately 8:08 PM the resident of the 100 block of Woods La., reported observing an suspicious person in their driveway. The resident reported seeing a black male in black sweat pants, wearing red Nike shoes walking out of his driveway. The black male entered a gray Volkswagen Jetta, occupied by two additional black males and left the area. When the resident went to check on his car, it showed obvious signs of having being entered.


Theft from Vehicle - Radnor Pedestrian Trail - Conestoga Rd.

On Saturday, 5/20/2023, at approximately 7:14 PM the victim reports their purse stolen from their vehicle while parked at the Radnor Pedestrian trail, on Conestoga Rd. The vehicle had its rear window smashed out and the purse removed from underneath the front seat.

Retail Theft - TJ Maxx Store - 550 E. Lancaster Av.

Store Security for the the TJ Maxx store, located at 550 E. Lancaster Av., reported a retail theft that occurred on Wednesday, 5/24/2023 at approximately 8:33 PM. Store security advised that three black females exited the store with approximately \$1,903.62 worth of merchandise without paying. They were seen on video surveillance leaving the area in a red Volkswagen Tiguan.

The Radnor Police respects citizens' privacy, civil rights, and civil liberties by emphasizing behavior, rather than appearance, in identifying suspicious activity. Factors such as race, ethnicity, and/or religious affiliation are not suspicious. The public should only report suspicious behavior and situations (e.g., an unattended backpack or package, or someone breaking into a vehicle or restricted area). Moreover, any physical descriptions are based on victim and witness statements provided to the Radnor Police at the time the incident was reported or developed through investigation.


