**Retail Theft - 201 Bryn Mawr Av. - the Wawa**

On Tuesday, 12/12/2023, at approximately 8:23 AM, a retail theft occurred at the Wawa, located at 201 Bryn Mawr Av. Store employees advise a black male, wearing a black jacket exited the store with multiple items without making payment.

**Theft of Mail - 400 block of Wyldhaven Rd.**

On Wednesday, 12/13/2023, the resident of the 400 block of Wyldhaven Rd. reports a package stolen from their home. The resident reports a package was placed in their mailbox at approximately 2:28 PM and when they went to retrieve the package at 4:00 PM, it was torn open and it had the contents removed.

**Phone Scam - Radnor Township**

On Wednesday, 12/20/2023, a resident of Radnor Township reported being victimized by a phone scam. The victim reported receiving a phone call at their residence, from an individual claiming to be from PECO. Telling the victim that their bill was past due, the caller made the victim open a Bitcoin account to make payment. Before realizing they were being scammed, the victim paid over \$4,000.00 to the scammer.

**Criminal Mischief - 775 E. Lancaster Av. - Goodness Bowls**

At 1:52 AM on Friday, 12/29/2023, the front window to Goodness Bowls, located at 775 E. Lancaster Av. was damaged. Video showed an unknown person throw a rock through the front window of the store.

**Criminal Mischief - 275 Bryn Mawr Av. - J Building parking lot**

On 12/25/2023 at approximately 11:00 PM damage was discovered to a 2019 Hyundai, parked in the lot of "J" Building of 275 Bryn Mawr Av. The vehicle had its driver's door handle ripped off and the door was dented. There was also peanut shells thrown onto the front windshield.

Behavioral Health Services Line Update

Open Discussion

Meeting called to order at 4:05pm with welcome and introduction of guest speaker by John Schwarz. Roundtable introduction by the group.

Dr. Deb Cunningham, System Vice President for Behavioral Health for Main Line Health formally introduced herself, professional experience, and tenure at Main Line Health. Initially started as a consultant for about a year and assumed role as vice president in January 2023. Dr. Cunningham presented and shared Main Line Health’s behavioral health services and programs. Below are some highlights from the presentation (PowerPoint attached):

- Main Line Health and Sheppard Pratt partnership – Sheppard Pratt has a long history of providing innovative behavioral health, including addition services. Partnership shows Main Line Health’s commitment to behavioral health services.
- Behavioral Health encompasses mental health – i.e., anxiety, depression; substance use disorders – drug and alcohol; and co-occurring disorders – mental health and substance use.
- Mental Illness – stressed mental illness as diseases of the brain. New treatments are more targeted.
- Facts: every forty second someone dies from suicide, rate of depression has increased since the pandemic, 25% of community (one in four adults) suffers from a behavioral health issue, 80% of people will not seek help due to stigma, access, and parity (equality). Dr. Cunningham shared her personal experience of a family member’s suicide.
- Access/Parity – Insurance coverage for behavioral health services. Providers must engage multiple payers, which may vary from county to county. Medicare vs Medicaid vs commercial insurance plans. Some cover inpatients but not outpatient services.



- Women's Emotional Wellness Center: Program for women across the life span, and especially great for women suffering from postpartum depression.
- Current projects and access to care:
  - Care of patients with opioid disorders. Pennsylvania has the third highest opioid overdose rate in the United States. Ms. Stevens mentioned that Delaware County is holding townhall meetings to discuss the opioid settlement funds. Dr. Cunningham indicated that Main Line Health is in discussions with the county to receive some of the settlement funds.
    - Ease of access for these patients.
    - Narcan in the emergency room. Patients can take the Narcan home.
  - Medicaid and other insurance contract negotiations – Pennsylvania has one of the lowest Medicaid reimbursements rates in the country. Working with county Managed Care Organizations (MCO's) and state representatives - advocacy for better reimbursement rates. Cost of care, staffing and psychiatrist are higher than what's received in reimbursement.
- What's in the future for Main Line Health and Sheppard Pratt
  - Completing market assessment of behavioral health services (mental health and substance use disorders) for all ages; identifying strengths and gaps in care; service line strategic plan; relationship and collaboration with stakeholders, including the local counties; advocating for enhance coverage from all payers, counties, and state; and seeking grant funding.
  - Mr. Schwarz – discussed under funding for behavioral health services. Bryn Mawr hospital received support from the community for the inpatient unit. Looking to collaborate with other health systems, including Penn and CHOP. Some gaps in Main Line Health behavioral health services, i.e., geriatric psych, and adolescent inpatient psych.
  - Group discussion and issues/areas of concern – anger and gun violence in the community – does the hospital provide gun locks to individual indicated presence of a gun in the home; increase in anger and violence towards healthcare workers, this has increased since the pandemic; Children and the elderly most vulnerable, police seeing more problems in the middle schools; hospital is providing de-escalation training for staff, trauma informed care, and resources in the emergency room; increase in depression; relationship with police departments; Montgomery County has a crisis line; and awareness of resources in the community.

**John Schwarz – Bryn Mawr Hospital Update:**

- US News sited Bryn Mawr Hospital for high performance in maternal care and Five Star rating from CMS/Leap Frog re: quality care indicators.
- Staffing is improving and reduction in resignations.
