Theft from Storage Unit - 1030 E. Lancaster Av. - Radnor House Condos

Indecent Act - Agnes Irwin School - 275 S. Ithan Av.

Employees of the Giant report on Tuesday, 4/23/2024, a blank male wearing a gray hoodie and a black face masked passed three counterfeit fifty dollar bills in the store. The black male was seen on video leaving the store in a silver Chevrolet Malibu.

The Radnor Police respects citizens' privacy, civil rights, and civil liberties by emphasizing behavior, rather than appearance, in identifying suspicious activity. Factors such as race, ethnicity, and/or religious affiliation are not suspicious. The public should only report suspicious behavior and situations (e.g., an unattended backpack or package, or someone breaking into a vehicle or restricted area). Moreover, any physical descriptions are based on victim and witness statements provided to the Radnor Police at the time the incident was reported or developed through investigation.

PANELIST BIOS

Superintendent Chris Flanagan- Radnor Police Department

Committed his life to community service through policing and volunteer work. Held various ranks in the department and commanded various special units. Lectured on topics such as Active Shooter, CPR, Stop the Bleed and for religious institutions, schools and civic organizations. Adjunct Instructor for the Anti-Defamation League on anti-bias in law enforcement training. Recipient of several service awards including Officer of the Year, Villanova Inaugural Caritas In-Town & Gown Award, and the Award of Valor presented by National Liberty Museum. A graduate of Northwestern University School of Police Staff and Command.

Superintendent T. Michael Beaty, Tredyffrin Police Department

T. Michael Beaty was unanimously appointed as police superintendent of the Tredyffrin Township Police Department in 2017. Beaty served as the Montgomery County Sheriff's Office chief deputy where he managed an organization of 110 sworn deputies and 25 civilians. In that capacity, he introduced new technology solutions to improve efficiency and implemented an improved policy management system to align with current law and best practices. Prior to the MCSO, Beaty served as chief of police for the Whitemarsh Township Police Department, where he served for 30 years. During that time, he was a patrol officer, served as a field-training officer and was a member of the Pennsylvania Attorney General's Montgomery County Drug Task Force. In 1993, Beaty was promoted to detective in the investigation division, where he served for seven years. He also served as the Bureau of Narcotics Investigation Drug Task Force coordinator. In 2003, Beaty was appointed to lead a patrol platoon before successive promotions to sergeant and eventually lieutenant in 2007. Beaty is a graduate of the FBI National Academy and the Northwestern University School of Police Staff and Command. He also holds a bachelor's degree in business management from Temple University.

Chief John String, Narberth Police Department

John String is the Chief of Police, Director of Public Health and Safety and Emergency Management Coordinator for Narberth since March 2023. Prior to that, he worked with the Lower Merion Township Police Department for 18 years. Experienced Police Officer and Supervisor with a demonstrated history of working in the public safety industry. Skills include training, evaluations, policy development, investigation, public safety, accreditation, and team building. Master's Degree in Public Administration from Arkansas State University and a Bachelor's degree focused in Aeronautics/Aviation/Aerospace Science and Technology from Embry-Riddle Aeronautical University. Post-Grad Certificate in Leadership and Management from Northwestern University's School of Police Staff and Command.

District Attorney Jack Stollsteimer, Delaware County

In 2000, Jack graduated from Temple University's Beasley School of Law and was appointed as an Assistant Delaware County District Attorney. Just one year later, in 2001, Jack was recruited to join the U.S. Department of Justice as the policy analyst and Special Assistant U.S. Attorney for the Project Safe Neighborhoods (PSN) gun violence reduction initiative in the Eastern

District of Pennsylvania. In 2004, Jack was appointed Assistant United States Attorney and assigned to lead a gun violence task force targeting the “Badlands” of North Central Philadelphia. Jack had the distinction of earning a 100% conviction rate in his four and a half years as a federal prosecutor. In 2006, Governor Edward G. Rendell appointed Jack as Pennsylvania’s Safe Schools Advocate for the Philadelphia School District. Jack was appointed Deputy State Treasurer for Consumer Programs in 2017. A long-time Delco resident, Jack graduated from St. Denis in Havertown and attended Archbishop Carroll before graduating from Ridley Senior High School. Jack currently serves on the Board of Directors of the Delaware County Bar Association and is a founding member of the Delco Coalition for Prison Reform (CPR). In 2019, he was elected as the District Attorney for Delaware County.

Superintendent Richard Gusick, T/E School District

Dr. Richard Gusick became the Tredyffrin/Easttown School district’s superintendent in 2015. Gusick joined the Tredyffrin/Easttown School District in 1990 as a social studies teacher at Conestoga High School. He taught social studies for more than ten years before becoming assistant principal of Conestoga High School in 2003. As a teacher, Gusick was the recipient of numerous teaching awards including the College Board Award for Outstanding Teacher of Advanced Placement. In 2007, Gusick was transferred to the central administration office as Administrator on Assignment for Strategic Planning. In this role, he led the District Action Team process which involved the participation of hundreds of students, teachers, parents, community members and administrators. Gusick completed his Bachelor of Arts and Master of Science degrees at the University of Pennsylvania. He earned his Master of Arts degree at Pennsylvania State University at Great Valley and his Doctor of Education degree at the University of Delaware.

Superintendent Kenneth Batchelor, Radnor School District

Dr. Kenneth E. Batchelor joined Radnor Township School District in 2017 and has over 25 years of experience in public education, starting as a student teacher at Overbrook High School in Philadelphia. From there, he taught U.S. History, Economics and Legal and Political Systems at East Forsyth High School in Winston Salem, North Carolina before making his way back to Pennsylvania to teach Cultural Studies and Honors American Studies at Unionville High School. He was promoted to Assistant Principal in 2002, a position he held until 2005. He left Unionville to serve for two years as the Principal of Penncrest High School in the Rose Tree Media School District before returning to Unionville-Chadds Ford in 2007 to serve as the Assistant to the Superintendent. Prior to entering public education, Dr. Batchelor served as a Legislative Assistant for Congressman Hamilton Fish, Jr., attending hearings on healthcare, trade, defense and education as well as researching legislation and briefing the congressman and senior staff on legislative issues. Dr. Batchelor earned his Doctorate in Educational Leadership at Widener University, his Bachelors Degree in Political Science from Villanova University, and his Masters in Education from the University of Pennsylvania.

Superintendent Steven Yanni, Lower Merion School District

Dr. Steven Yanni became the Lower Merion School District Superintendent in 2023 and comes to Lower Merion from the Upper Dublin School District, where he served as Superintendent of Schools since July 2018. Prior to joining Upper Dublin, Dr. Yanni served as Assistant Superintendent and then Superintendent in New Hope-Solebury. He also served as a Supervisor

of Curriculum, Instruction and Assessments and as an elementary school principal in the East Pennsboro Area School District and as a Response to Instruction and Intervention Coordinator and teacher in the Twin Valley School District. He began his career as a teacher in Gaston County, N.C. Dr. Yanni earned his Doctorate in Education from Immaculata University, where he earned the Distinguished Dissertation Award. He also holds a Master's in Educational Leadership from Immaculata and Bachelor's in Education from the University of Pittsburgh – Johnstown. In 2022 he was the recipient of the Patricia J. Rabbi Peter Rigler, Temple Sholom, Broomall

Rabbi Peter Rigler has served as the Rabbi of Temple Sholom since 2009. Rabbi Rigler was ordained by the Hebrew Union College – Jewish Institute of Religion in 2002. He has also served as the Associate Rabbi at Reform Congregation Keneseth Israel of Elkins Park, Pa. for seven years. He engages in all aspects of Jewish living, including: worship services; life cycle events and teaching in the Religious School and Lifelong Learning program. Rabbi Rigler's interests include social justice, youth work, teaching and Israel. He is engaged also in the broader community. Serving as the President of the Marple-Newton Multi-faith group, serving on faculty as URJ Camp Harlam each summer, as a member of the board of Rabbis and various other groups. Rabbi Geri Newburge, Main Line Reform Synagogue

Rev. Todd Stavrakos, Pastor at Gladwyne Presbyterian Church

Pastor Todd Stavrakos was called to Gladwyne Presbyterian Church (GPC) in 2006. Before joining the staff at GPC, he served at a redeveloping congregation in southern New Jersey, and prior to that he served at a parish church in Cumnock, Scotland. Todd's primary focus is creating a ministry that is community-based and mission-oriented, seeking to take the Word of God into the community following Jesus Christ's example. Before entering into ministry, he spent ten years working in the political world, serving on Congressional staff in Washington, DC, and working on legislative issues and political campaigns in Pennsylvania. Todd received his undergraduate degree at Villanova University and his Master of Divinity at Princeton Theological Seminary. Another area of interest for Todd is interfaith dialogue. He is a leader in the Interfaith Partners for Peace as well as the Rabbi-Pastor Dialogue group he created with the Presbytery of Philadelphia and the Jewish Community Relations Council. He has participated in two interfaith trips to Israel/Palestine to learn about interfaith work and to build bridges of peace between Palestinians and Jews.
