- 46-2-402.11 Food preparation workers must wear hair restraints
 - 46-6-202.13 Must maintain a professional extermination company at minimum of 2 x per month
 - 46-4-202.13 Clean & sanitize the basement shelving
 - 46-6-201.11 clean the floors under the counters in the counters and sandwich prep station.
 - 46-5-205.11 Repair/replace the loose faucet on the hand sink.
 - 46-2—102.12(A) Post the current Food Inspection Report, CFM Certificate & Food License in plain view for consumers.
 - 46-5-203.12 Make the necessary repairs and place the 2nd bathroom back into service
 - 46-7-201.11 Store toxic materials in a separate location away from food products and containers
 - 46-6-201.16 Patch the hole in the front corner wall/floor section of the 2nd floor.
 - 46-3-304.14 Must have sanitized wiping cloths to clean food preparation surfaces
 - 46-3-301.11 there should be no bare hand contact with ready to eat foods
 - 46-6-101.11 All indoor wall & ceiling surfaces shall be intact, smooth and cleanable surfaces with no peeling paint

- A sign or placard in a location conspicuous to the consumer, informing the consumer that a copy of the most recent facility inspection report is available upon request (46-8-304.11(K)).
 - The Radnor Township health officer can provide a sign/poster that a facility *may* use if they choose.
 - Also acceptable would be the posting of the actual inspection report in lieu of the posting of the signage.
