- 46-6-201.16 * HOLES IN THE WALLS IN THE BASEMENTT LOWER LEVEL.
- 46-6-102.11 * THE FLOOR IS FILTHY DIRTY AND STAINED AND NEEDS PAINTED.
- 46-6-101.11 * THE KITCHEN NEEDS A THOROUGH OVERALL CLEANING AND SANITIZING.
- 46-6-101.14 * THE FLOOR UNDER THE COOKLINE IS BEGINNING TO BUILD UP OF GREASE AND FOOD ACCUMULATING NEEDS CLEANED.
