

## REMARKS

THIS IS A FOLLOW UP INSPECTIN FROM 11/17/15 WHEREAS THIS FOOD FACILITY HAD A FIRE ALONG THE COOKLINE. (SEE FIRE MRSHALL FOR REPORT). FIRE MARSHALL CLEARED THOSE ISSUES RELTED TO FIRE PROTECTION. THE FAT FRYER IS BEING REPLACED WITH A NEW UNIT BY A COMMERCIAL VENDOR.. LIKewise THE TYPE1 HOODS WERE SERVICED AND THE HOODS AND DUCTS WERE CLEANED. A FULL DETAILED CLEANING WAS CONDUCTED PRIOR TO PERMITTING THE FCILITY TO RE-OPEN. ANY QUESTIONABLE FOODS WERE DISCARDED AND ALL SURFCES AND EQUIPMENT WS CLEANED AND SANITIZED. OPERATOR PERMITTED TO RESUME OPERATIONS AS OF NOVEMBER 20, 2015.
