THIS IS A FOLLOW UP TO THE RECENT CHANGE OF OWNERSHIP OF THIS FOOD OPERATION. THERE WERE SEVERAL ITEMS OUTSTANDING FROM THE INITIAL INSPECTIONS THAT NEEDED CHECKED. THE BASEMENT HAD AN ACCUMULATION OF MICE DROPPINGS THROUGHOUT AND IN GENERAL DIRTY CONDITIONS WITH HEAVY FLY ACTIVITY. ADDITIONALLY, NONE OF THE ITEMS IDENTIFIED BY THE BUILDING INSPECTOR AS A CONDITION OF THE TEMPORARY C of O WERE COMPLETE. THE FOOD OPERATION WAS CLOSED UNTIL SANITATION STANDARDS WERE MET. SEE 09/15/16 INSPECTION REPORT.
