IN AS MUCH AS THIS FOOD OPERATION WAS CLOSED THERE WERE NO FOOD SAMPLES TAKEN, HOWEVER ALL COLD STORAGE UNITS WERE VERIFIED AS MAINTAINING PROPER TEMPERATURES AT OR BELOW 41f<. THIS IS A FOLLOW UP FROM MONDAY 09/12/16 WHERE THE FOOD OPERATION WAS CLOSED FOR FOOD CODE REASONS. A PROFESSIONAL EXTERMINATOR WAS CALLED TO TREAT FOR MICE, FLYS, AND ROACHES. AALL THE EQUIPMENT WAS CLEANED AND THE WALLS AND FLOORS SURROUNDING THE EQUIPMENT WERE CLEANED. SUFFICIENT PROGRESS WAS MADE AND THE FOOD OPERATION WAS PERMITTED TO RESUME OPERATIONS, AND ADVISED THAT FUTURE VIOLATIONS MAY RESULT IN ADDITIONAL PENALTIES. THIS IS A SUMMARY OF THE INSPECTION WITH THE SIGNED HAND WRITTEN REPORT KEPT ON FILE.
